# 1 Getting Started

---

## 1.1 Choosing a Thesis Style and Template

There are two thesis style options, each with multiple templates:

1. Traditional Style Thesis (multiple chapters/sections)
2. Journal Style Thesis (one medium-length, or several short-length, manuscripts)

Talk to your faculty advisor(s) and teammates (if applicable) about your desired thesis style and corresponding template. While all the templates have specific pages in common, you must decide on a template early and use it throughout the program.

The template you choose may depend on your research discipline and/or partner program participation requirements. All theses must be a minimum of 5,500 words regardless of the template used.

### 1.1.1 Traditional Style Thesis

There are 5 **traditional style** thesis templates to choose from:

1. Science, Technology, Engineering, and Math (STEM) – Microsoft Word\*
2. Science, Technology, Engineering, and Math (STEM) – LaTeX/Overleaf.com\*
3. Liberal Arts, Humanities, and Social Sciences – Microsoft Word
4. Creative Works – Microsoft Word
5. Caruth School of Dental Hygiene – Microsoft Word

\*Note: The STEM and Social Sciences Traditional Style Microsoft Word and LaTeX/Overleaf thesis templates are identical. Only students with experience with LaTeX are advised to use the template in Overleaf.

### 1.1.2 Journal Style Thesis

There are 2 **journal style** thesis templates to choose from:

1. IMRAD Subheadings – Microsoft Word
2. Custom Subheadings – Microsoft Word

## 1.3 Required and Recommended Technology

### 1.3.1 Known Issues with Google Docs, Word for Web, File Transfers

- **Updates:** Keep both your computer and your version installation of Microsoft Office up-to-date for the best template experience.
- **Web vs. Desktop:** Use caution when editing your template on Microsoft Office 365 for web (accessed through a browser or mobile app). Use of Microsoft Office for desktop (installed to your computer) is required for editing. Some advanced features built into the templates are not available in the web version and will become corrupted if edited on the web.
- **Google:** *Never* open or edit your template using Google Docs. Google Docs and Microsoft Word are not compatible. Use Google Drive as method for **file transfers only**. Only use Google Docs with the intention of copying and pasting your writing as plain text into your Microsoft Word or LaTeX/Overleaf thesis template. ### 1.3.5 Document Accessibility

URS theses are published to the Texas A&M Libraries' OAKTrust Repository where they are available publicly and globally. So that URS theses can be accessed and read by people of all abilities they must be submitted as accessible documents.

An accessible document is a document that is readable on a computer using screen reader software. The URS thesis templates in Microsoft Word have been built with document accessibility best practices in mind, including:

- Structuring the Microsoft Word templates using heading styles.
- Maintaining clear heading levels.
- Using fonts consistently.

Other ways you can maintain your document accessibility while you customize your thesis template are:

- Using bulleted or numbered lists.
- Limiting figures and tables that contain text.
- Using hyperlinks properly with appropriate alternative text.
- Indicate the Heading Row on tables.
- Including appropriately descriptive captions and titles for figures, tables, and equations.
- Not conveying information with color exclusively.
- Providing full transcripts for video and audio.
- Use Microsoft Word's built-in Accessibility Checker under the Review tab.

## ***1.4 Copyright and Ownership***

Undergraduate Research Scholars will own the copyright to their Undergraduate Research Scholars Thesis. This means that the original work in the thesis can still be submitted for publication in a scholarly journal. Because the OAKTrust Digital Repository is legally classified as a publication, care must be taken not to violate United States copyright laws. If an Undergraduate Research Scholars Thesis contains any material (pictures, figures, tables, text, etc.) taken from other copyrighted sources, the student and faculty advisor are responsible for determining if a letter of permission from the copyright holder should be included as a statement within the document or as supplemental material to allow its use in the thesis. This is true even if you are an author of the material. Ultimately, if a permission statement is required by the copyright holder, it must be included in the thesis and proper credit (dictated by the letter of permission) must be given in the text. The appropriate place for this attribution is the Acknowledgements page.

If you have already published material that you subsequently want to include as part of your Undergraduate Research Scholars Thesis, you should be aware of the agreement that you signed when the material was accepted for publication. At that time, you may have assigned copyright to someone else (a journal, for example) as publisher, and you may no longer possess rights. Publisher agreement forms can be modified before they are signed so that you retain the right to include the material in your thesis. When negotiating with the publisher, remember to inform them that the thesis will be available publicly available online. If you have not retained the right to use the material in the thesis, written permission must be obtained from the copyright holder to include the material in the thesis.

Proper credit, as instructed in the letter of permission, must be given in the text. A copy of the letter of permission should be included in the Appendix section in the thesis. The permission granter should also be acknowledged in the Contributors section on the Acknowledgements page in the thesis.

## ***1.5 Thesis Length***

All URS theses must have a minimum of 5,500 words of paragraph/body text by the final thesis deadline. This minimum word count includes body text in the Introduction through Conclusion sections, as well as body text in the Creative Artifact section (if using the Creative Works template). The minimum word count does not include text in the preliminary pages, references section, captions, figures, tables, or equations. Many Undergraduate Research Scholars write more than the minimum 5,500 word count. Keep this minimum word count in mind when planning out your thesis.

## 2 General Thesis Structure

The sections below make up the URS thesis and are described in detail in throughout this Thesis Formatting Guide. Requirements and expectations vary by section, template, and project.

## 2.2 Preliminary Sections

The **preliminary sections** are the same in all templates and must be placed in the order listed:

1. Title Page (**required**)
2. Research Compliance Certification (**required**)
3. Table of Contents (**required**)
4. Abstract (**required**)
5. Dedication (**optional**)
6. Acknowledgements (**required**)
7. Nomenclature (**optional**)

## 2.3 Main Body Sections

Main body sections vary by template and are comprised of:

- Headings (chapter, section, or manuscript titles)
- Subheadings (first-, second-, and third-order)
- Body Paragraphs and Lists

## 2.4 Figures, Tables, and Equations

Figures, Tables, and Equations refer to additional content that can be placed in the **main body sections** and/or **appendix(ces)** of the thesis. Figures, Tables, and Equations are defined as:

- **Figures:** Photographs, maps, drawings, illustrations, graphs, charts, scans, screen clips, diagrams, plots, schematics, and other types of images.
- **Tables:** A variety of informative and data tables, code, algorithms, and other sets of information displayed in tabular form, with rows and columns.
- **Equations:** A variety of mathematical expressions and formulae.

Use of figures, tables, and equations varies by project and author, but all figures, tables, and/or equations must be:

- Identified with a label and number
- Referenced in the main body of the thesis
- Accompanied by a title (for tables) or caption (for figures and equations)
- Consistently formatted throughout the thesis
- Placed within one page of the first reference in the main body text, or in an Appendix

## 2.5 Footnotes, In-text Citations, and References

Footnotes, In-text Citations, and References refer to notes and citations placed in the **main body sections** and the **References section** that corresponds with the in-text citations.

Use of footnotes is optional and *varies by project and author*:

- Footnotes are used primarily to avoid cluttering the main body of text, while still allowing further discussion of materials intended for clarification or additional detail.
- For example, a student in Chemistry may use footnotes to clarify supplementary information about a particular chemical compound or experiment. Conversely, a student in History may use footnotes to describe a book or article that may not be pivotal to the argument but still provides interesting information for the reader to consider.
- Footnotes can also be used to identify previously published information in a manuscript in the Journal Style templates.

Use of in-text citations and inclusion of corresponding References section(s) (also known as Works Cited, Bibliography, Sources, etc.) are *required in all templates*.

- A single citation style must be selected to use throughout the thesis. The use of the selected citation style must be consistent throughout the entirety of the thesis.
- The citation style used should be in accordance with the conventions of a common format for publications in your area of research. Consult your faculty advisor for further details on how to appropriately use in-text citations for your discipline. **You must choose from the available options (ACS, AMA, APA, Chicago, IEEE, and MLA).**
- All citations must be from sources you have actually used in your research and must be cited in the text and in the References section(s).

## 2.6 Appendix(ces) and Creative Artifacts

- The final section of the thesis is the Appendix.
- This section is *required* in the Creative Works template.
- The Appendix section is optional in all other templates, except in the Caruth School of Dental Hygiene Template where it is not included.

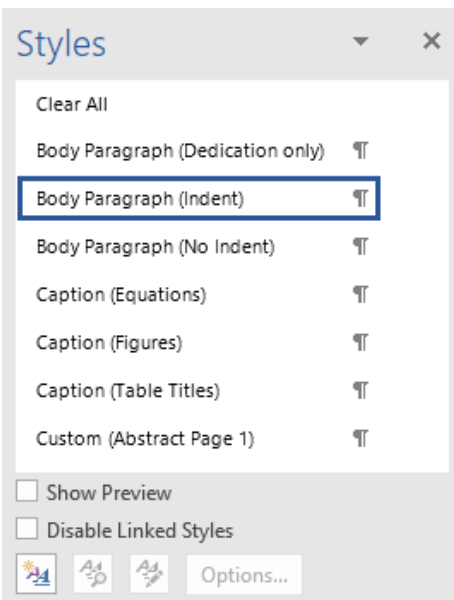
## 3 General Thesis Formatting

---

### 3.1 Styles

With the exception of the LaTeX template in Overleaf, all thesis templates are built in Microsoft Word and manage text formatting through the Styles pane. Additionally, certain portions of the Title, Research Compliance Certification, and Abstract pages are locked and require authors to enter information in fillable boxes within the document.

This guide describes the general rules for formatting a URS thesis as well as the collection of formatting settings, such as font and paragraph settings, for the Styles used in the URS templates. Consult this guide for formatting requirements and troubleshooting tips. Remember to always use the Styles built into your template. Keep in mind the requirements outlined in this section *apply to all templates* and are firm requirements regardless of project or discipline. Exceptions are noted when applicable.

#### 3.1.1 Keyboard Shortcuts

## **3.2 Document Page Specifications**

### **3.2.1 Margins**

- 1-inch margins on all sides of the document.
- All content (including figures and tables) must fit within these margins.

### **3.2.2 Size and Orientation**

- U.S. Letter Size (8.5 inches by 11 inches)
- The document must be in Portrait Orientation.
- An exception to the Page Orientation rule is described under [Document Page Specifications](#) in the [Figure, Table, and Equation Formatting](#) Section.

### **3.2.3 Footer (Page Numbers)**

- Page numbers be placed in the Footer section and begin on the Abstract preliminary page with the number 1. Continue numbering pages consecutively until the last page of the document
- Number pages using Arabic numerals. Do not use Roman numerals.
- The following preliminary pages will NOT be numbered:
  - Title Page
  - Research Compliance Certification
  - Table of Contents
- Header and Footer position specifications:
  - Set the footer to 0.5 inches from the bottom of the page.
  - Set the header to 0.5 inches from the top of the page. No text nor page numbers should be placed in the header section.
- Page number font specifications:
  - 12-point font size for page numbers.
  - Center alignment for page numbers.

## 3.3 Text and Font Specifications

### 3.3.1 Font Family

- Times New Roman font is required for all Preliminary and Main Body section text, as well as all Captions/Titles, Footnotes, In-text Citations, and References text.
- An exception to this rule is described under [Font Specifications](#) in the [Figure, Table, and Equation Formatting](#) section.

### 3.3.2 Text Size

- 14-point font size for headings.
- 12-point font size for subheadings.
- 12-point font size for all main body text.
- 10-point font size for figure captions, table titles, and equation labels.
- 10-point font size for footnotes.

### 3.3.3 Text Case

- UPPERCASE for all headings.
- Title Case for all subheadings.
- Sentence case for all other text.
- Note the following special exceptions:
  - UPPERCASE must be used for the thesis title on the Title preliminary page.
  - UPPERCASE must be used for author names on the Title preliminary page.
  - Title Case must be used for the thesis title on the Abstract preliminary page.
  - Sentence case can be used for Latin words used in headings and subheadings.

### 3.3.4 Typeface (Typographical Emphasis)

- **Bold** or *italics* may be used throughout the main body section for typographical emphasis. Be consistent in the way you use typefaces throughout the document.
- Note the following special exceptions:
  - *Italics* must be used for figure captions and table titles.
  - *Italics* may be used for Latin words in headings and subheadings.
  - *Italics* may be used for the Dedication text on the Dedication preliminary page.
- Keep in mind the required typeface for subheadings:
  - First-order subheadings must be **bold**.
  - Second-order subheadings must be *italics*.
  - Third-order subheadings must be regular text.
  - Examples of typographical emphasis used with subheadings:
    - e.g., first-order subheading:  
**Trauma in *The Things They Carried***
    - e.g., second-order subheading:  
*Comparing Amphibian Species: Heterodon platirhinos and Hyla cinerea*

## **3.4 Paragraph Specifications**

### **3.4.1 Paragraph Alignment**

- Center alignment for headings
- Center alignment for page numbers
- Left alignment for subheadings
- Left alignment for main body text (full-justification is not allowed)
- Left or center alignment for figures, tables, and equations
- Left or center alignment for figure captions and table titles
- Right alignment for equation labels

### **3.4.2 Paragraph Line Spacing**

- Double spacing must be used for headings, subheadings, and main body text.
- Set the “space before” paragraph to 0 points for headings, subheadings, and main body text.
- Set the “space after” paragraph to 32 points for headings.
- Set the “space after” paragraph to 0 points for subheadings.
- Note the following special exceptions where single spacing must be used:
  - Figure captions and table titles
  - Individual reference entries on the References or Works Cited pages/sections
- Note the following special exceptions where single spacing may be used:
  - Figures, tables, and equations
  - Long, blocked, and inset quotations
  - Itemized and bulleted lists

### **3.4.3 Paragraph Indentation**

- First line indentation of 0.5 inches must be used for main body text.
- Do not indent subheadings.

## ***3.5 Additional Text Specifications***

### **3.5.1 Text Layout and Placement**

- Headings must be placed at the top of the page.
- Subheadings must be placed on a line by themselves.
- Move orphan subheadings to the top of the next page. An orphan subheading is one that is left all alone at the bottom of a page without at least one line of its corresponding paragraph text.
- Do not set main body text into columns.

### **3.5.2 Text Color**

- The color of headings, subheadings, and all other text should be set to black (be careful when copy/pasting as some text will come in off-gray).

### **3.5.3 Numbering**

- Numbering of specific headings and subheadings is dependent on your template.
- All numbering should be consistent throughout the document and in the Table of Contents.

### **3.5.4 Punctuation in Thesis Titles, Headings, and Subheadings**

- Ending punctuation should not be used in the thesis title unless it is a question.
- Ending punctuation should not be used in headings nor subheadings unless the heading or subheading is a question.

### **3.5.5 Hyperlinks**

- Hyperlink URLs that appear in the text, including in reference entries and citations.
- Double check that all URLs included in the text are active.

## 4.1 Title Page (required)

The formatting of the Title page is identical in every template.

This section describes general formatting rules. Do not modify the Custom Styles unless approved by LAUNCH: UGR. Consult this section for formatting requirements and troubleshooting tips.

### 4.1.1 All Templates

#### Thesis Title Heading

No ending punctuation unless a question. Must be in ALL CAPS. Must match title on Abstract page and in STSS.

#### Thesis Statement and Author Name(s)

Must match official student records. Must match names on Title, RCB, and Abstract pages.

#### Submittal Statement

Do not alter statement.

#### Distinction Name

Do not alter statement.

#### Faculty Research Advisor(s)

##### Approval Statement

Must match names on Abstract page. Include only approved faculty members. Be sure to include pre- or post-nominal letters.

#### Program Completion Date

NOT graduation or class year.

#### Author(s) Major(s)

Must match official student records. Can include tracks and secondary majors. No minors.

#### Copyright Notice and

##### Author Name(s)

NOT graduation or class year. Must match official student records. Must match names on Title, Research Compliance Certification, and Abstract pages.

## 4.1.2 Thesis Title Heading

- No ending punctuation unless a question.
- Must be in ALL CAPS.
- Must match title on Abstract page and in STSS.

## 4.1.3 Thesis Statement and Author Name(s)

### 4.1.3.1 Individual Thesis

- Name must match official student records.

## 6 Figure, Table, and Equation Formatting

---

This section describes both the general formatting rules and the formatting settings for Styles used in the Word templates.

**Consult the templates for additional instructions and examples. More in-depth guidance on Figures, Tables, and Equations will be provided in the Thesis Formatting Workshops. Supplemental handouts and tutorials will also be provided.**

The Figures, Tables, and Equations are the most complex portions of the thesis templates. The proper use of Styles for captions, titles, and labels is required to maintain consistent formatting of added content throughout the thesis.

The requirements outlined in this section are *exceptions* to the formatting requirements outlined in the [General Thesis Formatting](#) section. Keep in mind the requirements outlined in this section *apply to all templates* and are firm requirements regardless of project or discipline. Exceptions are noted when applicable.

## 6.1 Document Page Specifications

### 6.1.1 Orientation

- Landscape Orientation is acceptable for figures and tables that do not optimally fit in Portrait Orientation. Figures and tables set to Landscape must begin at the top of a new page and with labels facing in the same direction. Do not include sideways labels.

## 6.2 Font Specifications

### 6.2.1 Font Family

- The font family used for figures and tables created in the document must be Times New Roman.
- The font family used for figure captions and table titles must be Times New Roman.
- The font family used for equations and equation labels can be either Times New Roman or Cambria Math.
- The font family used *in* figures can vary if absolutely necessary. We **strongly recommend** using Times New Roman for **all text** in your document. However, if you must deviate from Times New Roman, we recommend choosing one of the following font families for optimum accessibility and readability:
  - Arial
  - Calibri
  - Georgia

### 6.2.2 Size

- Figure captions, table titles, and equation labels must be 10-font size.
- The font size used in figures (i.e., images) can vary; however, the minimum size allowed is 10-point.

### 6.2.3 Typeface (Typographical Emphasis)

- **Bold** or *italics* may be used throughout figures, tables, and equations for typographical emphasis. Be consistent in the way you use typefaces throughout the document.
- *Italics* must be used for figure captions and table titles.

## 6.3 Paragraph Specifications

### 6.3.1 Alignment

- The alignment of figures, tables, and equations and their corresponding captions and titles can be set to left or center. Be consistent throughout the document, using the same alignment for all figures, tables, and equations included. For instance, you should not left align figures and center align equations—all figures and equations should be either left aligned or center aligned.
- Multi-part figures, tables, and equations must be clearly identified.
  - e.g., Figure 1-A, Figure 1-B, Figure 1-C, etc.
  - e.g., Table 1A, Table 1B, Table 1C, etc.
- Any additional information that is to be included with tables or equations can be placed as notes below the tables or equations.

## 6.4 Additional Specifications

### 6.4.1 Labeling and Numbering

- Figures must be labeled consistently, numbered consecutively, and described in a caption. Captions must be placed below figures.
- Tables must be labeled consistently, numbered consecutively, and described in a title. Titles must be placed above tables.
- Equations must be labeled consistently and numbered consecutively. Labels must be placed to the right of equations.
- Captions and titles included as part of an image must also be placed as readable text in the document (i.e., copy and paste, or type out, text embedded in images).
- The label used for figures, tables, and equations and their corresponding captions and titles can vary. We strongly recommend using the terms “Figure,” “Table,” and “Equation,” but be consistent if you choose to deviate from that language and be intentional with what you are labeling.
- Use a period, colon, or dash to separate the figure, table, or equation label and number from its corresponding caption or title. Keep this formatting choice consistent throughout all your figures, tables, or equations.
- Figure, table, and equation numbering should be consecutive throughout the entire document. See exceptions for numbering in the Appendix:
  - Labeling and numbering in the Appendix(es) section:
    - If including a single Appendix section:
      - e.g., Figure A.1., Figure A.2., Figure A.3., etc.
    - If dividing the Appendix into multiple sections:
      - e.g., Table A.1., Table A.2., Table A.3., etc.
      - e.g., Figure B.1., Figure B.2., Figure B.2., etc.

## 6.4.2 Layout and Placement

- Figures, tables, and equations should not be placed alongside text. Do not use columns to format figures, tables, equations, or text. Figures, tables, and equations and their corresponding captions/titles should be placed on a line by themselves.
- Figures, tables, and equations should be placed within one page of the first in-text reference. If you have a figure, table, or equation referenced multiple times throughout the document, consider placing it in the Appendix section.
- Note the following special instructions for figures and tables that cannot be contained within a single page:
  - Consider placing large figures and tables in the Appendix section.
  - The full caption or title must be repeated, including the label and number, on all subsequent pages the figure or table is placed. The word “continued” must be placed at the end of the repeated captions or titles.
  - Table column or row headings should be repeated on all subsequent pages the table is placed.
  - The line that indicates the end of the completed table should be placed on the last page of the table only.
  - When there is not enough space for a long caption on the page with the figure, resize the figure and/or push the figure and caption to the next page. Do not separate figures from their captions.

## 6.4.3 Color and Quality

- Figures, tables, and equations may use color. Color variations used to illustrate differences in tables should be distinct and clearly labeled.
- All content must be of publishable quality. Beware of using scanned documents and/or images as they may be blurred or dark.

## 7.1 Footnotes

### 7.1.1 General Footnote Formatting Rules

- Footnotes must be numbered consecutively and placed at the bottom of the same page where their number is in the text.
- Footnotes are separated from the rest of the text on the page with a line.

## 7.2 In-text Citations

### 7.2.1 General In-text Citation Formatting Rules

- There are two methods of citing sources in the main body text: Parenthetical and Numerical
- The in-text citation method you choose and the information included in the in-text citation depends on your selected citation style.
- Consult your faculty advisor on the most appropriate citation style. **You must choose from the available options (ACS, AMA, APA, Chicago, IEEE, and MLA).**
- In-text Citations should be formatted according to the main body paragraph text using the Body Paragraph (Indented) Style.

#### 7.2.1.1 Parenthetical In-text Citations

Citation Styles that utilize parenthetical in-text citations include but are not limited to:

- American Psychological Association (APA)
- Modern Language Association (MLA)
- Chicago Manual of Style (Chicago, Author-date)

Examples of in-text citation formatting include but are not limited to:

- (Name, Year, p. #)
- (pp. ###)
- (Name, Year)
- Name (Year)

#### 7.2.1.2 Numerical In-text Citations

Citation Styles that utilize numerical in-text citations include but are not limited to:

- Institute of Electrical and Electronics Engineers (IEEE)
- American Medical Association (AMA)
- American Chemical Society (ACS)
- Chicago Manual of Style (Chicago, Notes and Bibliography)

Examples of in-text citation formatting include but are not limited to:

- A number in brackets [1]
- A number in parentheses (1)
- A superscripted endnote <sup>1</sup>

## 7.3 References

### 7.3.1 General References Formatting Rules

- Format each reference (capitalization, punctuation, and ordering of information; alphabetized, alphabetized and numbered, or non-alphabetized and numbered; use of italics, quotation marks, and bold type) according to the conventions of your selected style (MLA, APA, AMA, IEEE, Chicago, etc.). Be sure to follow the same citation style for all reference entries.
- Reference entries are set to be single spaced. The amount of space in between each reference entry equals a double space.

### 7.3.2 References List Text in Word Styles

- List (References)

#### 7.3.2.1 Font settings

- Font: Times New Roman
- Font size: 12-point
- Font style: Regular
- Font color: Black

#### 7.3.2.2 Paragraph settings

- Alignment: Left
- Spacing:
  - Line spacing: Single space
  - Space before paragraph: 0-point
  - Space after paragraph: 24-point
- Indentation: Hanging by 0.5"

## 8 Appendix(ces) and Creative Artifact Sections Formatting

**Consult the templates for additional instructions and examples. More in-depth guidance on Appendixes and Creative Artifacts will be provided in the Thesis Formatting Workshops. Supplemental handouts and tutorials will also be provided.**

Appendices and Creative Artifacts follow guidelines from the Main Body Sections and Figures, Tables, and Equations Sections. The proper use of Styles for captions, titles, and labels is required to maintain consistent formatting of added content throughout the thesis.

The requirements outlined in this section are *exceptions* to the formatting requirements outlined in the [General Thesis Formatting](#) section. Keep in mind the requirements outlined in this section *apply to all templates* and are firm requirements regardless of project or discipline. Exceptions are noted when applicable.

### 8.1.1 General Appendix Formatting Rules

- The Appendix is required in the Creative Works template. It is optional in all other templates (except in the Caruth School of Dental Hygiene template where an Appendix is not allowed).
- Materials placed in the Appendix must follow the Main Body Section Formatting and Figure, Table, and Equation Formatting guidelines.
- If using Traditional Style templates, the Appendix section must be placed directly after the References List section.
- If using Journal Style templates, the Appendix section must be placed directly after the all-inclusive Conclusion section.
- The portion of the thesis can be divided into multiple sections using A, B, C, etc. to delineate sections, but must also have a unique section title.
  - e.g., Appendix A: Data Sets, Appendix B: Photographs
- Materials placed in the Appendix must be referenced at least once in the main body section.
  - If dividing the Appendix into multiple sections:
    - e.g., Table A.1., Table A.2., Table A.3.
    - e.g., Figure B.1., Figure B.2., Figure B.2.
- The Appendix should not be a separate from the thesis document unless approved by LAUNCH: UGR.
- The Appendix should maintain the consecutive page numbering of the document.
- **Data Sets:** Include as table with proper titles or host data on a service such as the Texas Data Repository and include permalink in thesis.
- **Written Creative Work:** Consult with your faculty advisor on the norms and formatting used for pieces such as screen writing, poetry, short stories, and/or dramaturgy. Use titles and other stylistic practices that are appropriate for your genre.

- **Video, Sound Files, and/or Other Digital Media:** To include video and/or sound files, you may need to send them as supplemental files to the LAUNCH: UGR office to be uploaded for you. If you have questions about uploading video and/or sound files, contact our office. All videos must be submitted in MP4 format. Authors must agree to a separate licensing agreement prior to the final thesis submission. Contact [ugr@tamu.edu](mailto:ugr@tamu.edu) before filming to acknowledge understand of what is required of you.
- Creative Artifacts that cannot be included in the thesis PDF (such as audio and/or video files) must be submitted LAUNCH: UGR at [ugr@tamu.edu](mailto:ugr@tamu.edu). If the thesis includes separate files, a description of these files must be placed in the main document or in the Appendix section. If you have questions about how to submit other materials as part of your thesis, contact LAUNCH: UGR at [ugr@tamu.edu](mailto:ugr@tamu.edu).
